N16 extending from a point 70m metres East of Diffreen Bridge in the townland of Diffreen for a distance of 4.55 kilometres to the townland of Gortnagrelly in Co Sligo.

Speed Limit will apply from, 9am on the 25th October 2021 to 5pm on the 25th October 2022 or on completion of the works, whichever is the shortest period.
